- 187.1.1. 08/2016/17386 Variation of condition 2 & 4 of approval 08/2016/16863 to allow a revised site layout and allow Caravan 1 to be occupied as permanent living accommodation by site warden at Toll Bar Gardens, Wennington Road, Low Bentham

- 187.1.2. 08/2016/17619 Alterations & extension to dwelling & proposed detached garage at Rose Cottage, Wenning Avenue, High Bentham  
There were no objections to the alteration & extension of the dwelling, but the size and design of the garage - rendered walls under a corrugated roof - were considered to be out of keeping with other properties in the area. It was suggested that the proposed garage needed to be less 'agricultural' looking and should be stone clad with a 'slate-looking' (composite tile or similar) roof.
